After considering the said proposal and the documents attached therewith, the committee has passed the provisional order on 08.12.2021 for the academic year: 2021-22 Primary Section Std. 1 to 8, Secondary Section Std. 9 (CBSE English Medium), For Primary Std. 1 Rs. 29000/-against Rs.36750/-, For Primary Std. 2 & 3 Rs. 26000/-against Rs.36750/-, For Primary Std. 4 & 5 Rs. 25500/-against Rs.36750/-, For Primary Std. 6 Rs. 25000/-against Rs.39900/-, For Primary Std. 7 & 8 Rs. 23500/-against Rs.39900/-, For Secondary Std. 9 Rs. 23,500/-against Rs.45,000/-, for the academic year: 2021-22.

2. Then after committee gone through the latest proposal of the school for the A.Y: 2022-23, for the CBSE Standard in all sections and also gone through the representation of the school trust and the request of trust enhanced the fee structure (20%) then GSEB Board as per norms of FRC. and by considering the class rooms and teacher's Salary. and as per the above submission committee founds that in the CBSE Standard per class only (40) student's accommodated in place of (60) student's as per GSEB Standard and also teacher's rank also required hike and also extra class room's and advanced standard of educations and technology are required so there is difference of (20%) found reasonable. Hence following final order passed for the A.Y: 2022-23 for Primary Section, Secondary Section and Higher Secondary Section (General & Science).

 You are further directed that any excess fees charged from the students over and above the above mentioned ceiling shall have to be refunded to the students.

Terms and conditions:

- 1 The school is not permitted to collect fees more than the final fees determined for the academic year: 2022-23.
- 2 The school is permitted to collect the fees for the academic year 2022-23 and 2023-24 and 2024-25 by adding 5% increase in the final fees determined by the committee for the academic year 2022-23 as per the CBSE proposal by the school for all sections.
- 3 It is further made clear that the School is not permitted to collect fees under any head other than the head of tuition fees, term fees as permitted and admission fees of 1 month only in case of new admission and thereby causing any extra burden on the students. However, total of all these fees should not exceed the final fees determined by the committee.
- 4 It is also made clear that the School should either return the excess fees collected by the School for the year 2022-23 or give adjustment thereof, in the remaining installments of fees of 2022-23.
- 5 Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 6 If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application before the Fee Revision Committee along with challan of Rs.10,000/- by way of filing fees.

7 The School is directed to place the final order determining the final fees on its notice board as well as its website respectively in Gujarati and English.
